MEDC 2006

In 1992, MEDC created the Capital Access Program (CAP) to assist local partner banks in mitigating some of the risk associated with small start-up businesses. Structured as a public/private loan reserve program, CAP matches contributions to the reserve fund made by participating banks and borrowers. Banks can withdraw from this risk-reserve fund to cover losses on loans made through the program. The bank makes the loan approval determination, structures the loan and files a simple one-page form with MEDC to enroll.
